## ABOUT THIS SERIES

The *Holy Nativity Patristic Library* presents the foundational texts of the early Christian Fathers in carefully typeset pocket editions. Each volume is drawn from the public-domain English translations of the *Ante-Nicene Fathers* and the *Nicene and Post-Nicene Fathers* – the thirty-eight-volume collection edited by Philip Schaff and his collaborators between 1886 and 1900, which remains the most comprehensive English-language gathering of the patristic writings ever assembled.

We have undertaken to issue these works one at a time, as portable single-author editions, so that they may travel where the original folio volumes cannot – in a coat pocket, on a long flight, beside a hospital bed. Each volume preserves the Schaff translation and the translator's introduction. The foot-

note apparatus is retained where it serves the text; we have set aside those notes that pertain only to the nineteenth-century volume context, and any commentary at variance with the Orthodox confession of the Fathers themselves. We add a subject index and a scripture index for the text in hand.

The texts are typeset in IM Fell English, a face cut by John Fell in seventeenth-century Oxford and freely available again through the work of Igino Marini. The Greek is set in Philokalia, designed for the Athonite tradition.

§ 1. Introductory.-The subject of this treatise: the humiliation and incarnation of the Word. Presupposes the doctrine of Creation, and that by the Word. The Father has saved the world by Him through Whom he first made it	21

- § 2. Erroneous views of Creation rejected.  
 (1) Epicurean (fortuitous generation). But diversity of bodies and parts argues a creating intellect.  
 (2.) Platonists (pre-existent matter.) But this subjects God to human limitations, making Him not a creator but a mechanic. (3) Gnostics (an alien Demiurge). Rejected from Scripture 24
- § 3. The true doctrine. Creation out of nothing, of God's lavish bounty of being. Man created above the rest, but incapable of independent perseverance. Hence the exceptional and supra-natural gift of being in God's Image, with the promise of bliss conditionally upon his perseverance in grace 27
- § 4. Our creation and God's Incarnation most intimately connected. As by the Word man was called from non-existence into being, and further received the grace of a divine life, so by the one fault which forfeited that life they again incurred corruption and untold sin and misery filled the world 30

- § 5. For God has not only made us out of nothing; but He gave us freely, by the Grace of the Word, a life in correspondence with God 32
- § 6. The human race then was wasting, God's image was being effaced, and His work ruined. Either, then, God must forego His spoken word by which man had incurred ruin; or that which had shared in the being of the Word must sink back again into destruction, in which case God's design would be defeated. What then? was God's goodness to suffer this? But if so, why had man been made? It could have been weakness, not goodness on God's part 35

- § 7. On the other hand there was the consistency of God's nature, not to be sacrificed for our profit. Were men, then, to be called upon to repent? But repentance cannot avert the execution of a law; still less can it remedy a fallen nature. We have incurred corruption and need to be restored to the Grace of God's Image. None could renew but He Who had created. He alone could (1) recreate all, (2) suffer for all, (3) represent all to the Father

- § 8. The Word, then, visited that earth in which He was yet always present ; and saw all these evils. He takes a body of our Nature, and that of a spotless Virgin, in whose womb He makes it His own, wherein to reveal Himself, conquer death, and restore life

§ 9. The Word, since death alone could stay the plague, took a mortal body which, united with Him, should avail for all, and by partaking of His immortality stay the corruption of the Race. By being above all, He made His Flesh an offering for our souls; by being one with us all, he clothed us with immortality. Simile to illustrate this 42

§ 10. By a like simile, the reasonableness of the work of redemption is shewn. How Christ wiped away our ruin, and provided its antidote by His own teaching. Scripture proofs of the Incarnation of the Word, and of the Sacrifice He wrought 44

- § 11. Second reason for the Incarnation. God, knowing that man was not by nature sufficient to know Him, gave him, in order that he might have some profit in being, a knowledge of Himself. He made them in the Image of the Word, that thus they might know the Word, and through Him the Father. Yet man, despising this, fell into idolatry, leaving the unseen God for magic and astrology; and all this in spite of God's manifold revelation of Himself 47
- § 12. For though man was created in grace, God, foreseeing his forgetfulness, provided also the works of creation to remind man of him. Yet further, He ordained a Law and Prophets, whose ministry was meant for all the world. Yet men heeded only their own lusts 50

§ 13. Here again, was God to keep silence?  
to allow to false gods the worship  
He made us to render to Himself?  
A king whose subjects had revolted  
would, after sending letters and  
messages, go to them in person.  
How much more shall God restore  
in us the grace of His image. This  
men, themselves but copies, could  
not do. Hence the Word Himself  
must come (1) to recreate, (2) to  
destroy death in the Body

§ 14. A portrait once effaced must be re-  
stored from the original. Thus the  
Son of the Father came to seek,  
save, and regenerate. No other way  
was possible. Blinded himself, man  
could not see to heal. The witness  
of creation had failed to preserve  
him, and could not bring him back.  
The Word alone could do so. But  
how? Only by revealing Himself as  
Man

- § 15. Thus the Word condescended to man's engrossment in corporeal things, by even taking a body. All man's superstitions He met halfway; whether men were inclined to worship Nature, Man, Demons, or the dead, He shewed Himself Lord of all these 58
- § 16. He came then to attract man's sense-bound attention to Himself as man, and so to lead him on to know Him as God 60
- § 17. How the Incarnation did not limit the ubiquity of the Word, nor diminish His Purity. (Simile of the Sun.) 62
- § 18. How the Word and Power of God works in His human actions: by casting out devils, by Miracles, by His Birth of the Virgin 65
- § 19. Man, unmoved by nature, was to be taught to know God by that sacred Manhood, Whose deity all nature confessed, especially in His Death 68
